Committee Reports

Water Quality

Crow Wing County has contracted RMB Labs to provide **testing for the microscopic zebra mussel offspring** (called “veligers”). Lakes currently not infested with zebra mussels were invited to participate. The testing is planned for July, which is generally when there is the highest concentration of veligers in the water column.

Horseshoe Lake participated in the program and Jerry Martin attended the veliger testing training on June 19 and collected samples on **July 1. Samples were taken at two locations on the east bay and one location on the west bay.** The samples have been delivered to RMB and we are waiting for the results. We hope for a good report!

Please check your docks and boat lifts when removing them this fall for any signs of zebra mussels. Report occurrences of invasive species to

AIS Inspections Continue!

AIS Inspections continue with 400 hours of grant money! Inspections at the boat landing will continue through the summer and into September. Through the 4th of July weekend we have used 56% (225 hours) of our 400 hours. As many of you know, we are fortunate to have an uninfected lake and one of the top 3 cleanest lakes in the state! We are surrounded by invasive species lakes, and need to do our utmost at protecting it. While we have over \$30,000 in our fund to combat an infestation, it is just a drop in the bucket to combat an infestation. Hopefully, the grant money will continue and we can stay on the positive side of this ongoing issue. With the annual dues coming up (half going to protection fund), we also accept donations to the fund — see your dues statement for details.

If you see any issues with inspectors please send me an email with the day and time and I can forward it to the coordinators. **We will have one of the coordinators Jacob Hradsky at our annual meeting to answer questions and concerns.**

Fishing Management



We are well into the fishing season, and for those who do not have a copy of the **FISHING REGULATIONS**, or have not bothered to read them, I will mention a few of them.

- Regulation: It is **illegal to dump unwanted minnows, leeches, or worms into the lake.** (page 21)
Regulation: It is **illegal to dispose of fish guts or parts (after cleaning fish) or dead fish in the lake.** (page 26)
Regulation: It is **illegal to fish with an unattended line.** (page 22)
Regulation: It is **illegal to fish with more than one line.** (page 20)
Regulation: It is **illegal to use parts of game fish for bait.** (page 21)
Regulation: Bow-fishing has become quite popular, but it is only allowed for rough fish, including carp, bullheads, suckers, redhorse, or buffalo fish.
It is **illegal to take or kill game fish.** (page 54)

DAILY AND POSSESSION LIMITS are the same, and are as follows:

| Perch | – 20 |
| Walleye | – 6 (not more than 1 over 20 inches) |

NOTE: Please let me know if anyone catches a walleye in Horseshoe Lake

Being a good fisherman or fisherwoman and being a good steward of the lake includes some **ETHICS**:

- * Don't litter with fishing line, styrofoam, plastic bags, or garbage.
- * Keep only the amount of fish you can use.
- * It is recommended that we not use lead sinkers or tackle, as it can be deadly to waterfowl, etc.
- * If you catch bullheads, please do not put them back in the lake (we have an excessive bullhead population)

Last, but not least, our lake does not have any invasive species, which is **UNIQUE** in Crow Wing County. According to the DNR, in Crow Wing County:

- Zebra mussels present in 32 lakes, Mississippi River, Pine River, and 8 unnamed lakes, ponds/wetlands
- Milfoil has infected 7 lakes and the Ripple River

Let's all do our best to keep our lake free of invasive species.

On a trip around the lake on July 4th early morning, we saw two sets of loons with their babies (one baby for each pair). Our conclusion was that the pair of loons that nested in the channel between the lakes had a baby and the other baby came from the bay by the public landing. In our memory, this is the first time that pair hatched and got the baby beyond a week old.

When we submit our report, the DNR would like information about **herons** and where they nested. We have seen as many as five herons during one ride but haven't been able to see where they nested.

Alert!!! We saw more than 16 geese or goslings.

The dues statements are attached to this newsletter and they are \$35 again this year. (Mail it to the address on the form or bring to the annual meeting.) Note that part of your dues goes into the **LAKE PROTECTION FUND**.

- At the 2014 Annual Meeting, the **Lake Protection Fund** portion of the dues was increased from \$10 to \$20 to help build the “war chest” to fight off AIS problems.
- Though your dues (and your generous contributions **in excess of \$20**) we have been able to add to this fund. \$6340 was contributed to the fund in 2014-2015 from Horseshoe Lake Owners.

The State of Minnesota has also played a helping hand in providing funds to fight AIS.

- Because of the Minnesota Legislature’s committing funds to Crow Wing County, and the County’s allocation of those funds to those lakes and Lake Associations who were being “proactive in protecting their lakes”, we now have funding for Lake Access Inspectors each weekend on Horseshoe Lake.

Keep up the donations in the 2015-2016 **because if we do get into a fight with AIS, the \$31,913.05 (current fund balance) will be a drop in the bucket for what we will need.**

I need to point out that these donations are not tax deductible because we are not a 501(c)(3) organization.

Many of us have wondered about the trees taken out along Mission Park Road.

The 42 acres of trees were property of the State of Minnesota, Crow Wing County and the Mission Township, and were recently sold for timber. Clean-up of the area will continue through the fall. Trees will be replanted, and buffer strip along the road. We were told it will take 8 years for the buffer strip to have an impact (similar to north part of East Horseshoe Lake Road).

OTHER TIPS TO MAKE LAKE LIFE EASIER ...

Heather says...This is a GREAT TOOL for anyone wanting to replace lawn with some native plants. These plants can also be used in the rain gardens. As I discuss projects with landowners many of them who have reduced their lawns and beaches say a 20-25 foot beach is just enough for the grandkids, kids, dogs and not too much to maintain throughout the summer.

This is a GREAT TOOL also for anyone interested in native flowers for pollinators too. Even though I don't live on a lake I have taken the back corners and along my fence (no weed whipping!) and replaced these with native plants for pollinators. It looks great and is less maintenance for me.

Another tip to point out is that Crow Wing SWCD has grants to help cost share shoreline buffers and rain gardens. They can be reached at [218-828-6197](tel:218-828-6197). Technicians Darren Mayer and Beth Hippert can assist landowners with a plan, doing it themselves or hiring a contractor. This is a great program and will run through next summer.

REVISED BY-LAWS

(proposed for August 2015)

PREAMBLE – The purpose and general nature of the HORSESHOE LAKE PROPERTY OWNERS ASSOCIATION (formed in 1982) is to promote the prudent use and development of the Horseshoe Lake area, including maintaining the delicate ecological balance which must exist between the lake and adjacent watershed area. Specific areas of interest include water quality, aquatic vegetation, fishing, Mission Park, roads, water safety and boating, security/police protection, taxation and membership. The Association endeavors to work cooperatively with government, business, professional associations and private individuals to protect and preserve the lake and the surrounding environment.

ARTICLE I – MEMBERS

- 1.1 There shall be members with voting rights. Each parcel of property is entitled to one vote.
- 1.2 Persons owning real property fronting on Horseshoe (Sandbar) Lake, or adjacent thereto, shall be voting members.
- 1.3 The membership may establish a class or classes of non-voting members upon such conditions and terms as it from time to time deems appropriate.
- 1.4 The membership, at the annual meeting, shall assess dues or other payments to be made by all classes of members. Dues are assessed and payable coinciding with the fiscal year which begins August 1st each year.

ARTICLE II – MEMBERSHIP MEETINGS

- 2.1 There shall be an annual meeting called by the Board of Directors the first Saturday in August. Written notice shall be mailed or emailed to each member at least ten days in advance of the meeting.
- 2.2 Business conducted at the annual meeting shall include, but not be limited to, election of officers, committee reports, treasurer's report, or any other business properly placed on the agenda.
- 2.3 Special meetings of the membership may be called upon request of the President, Vice-President, or a majority of the Board of Directors. Notice of such meeting shall be mailed at least ten days in advance of the meeting. At such special meetings only matters detailed in the notice may be considered.
- 2.4 Quorum shall be a majority of voting members present.

ARTICLE III – BOARD OF DIRECTORS

- 3.1 The Board of Directors shall consist of the officers of the association, six directors and the immediate past president.
- 3.2 The Board shall conduct the business of the association between annual membership meetings.
- 3.3 The Board shall consider all policies, business, and finances of the association; review decisions of all committees and Task Forces; make recommendations that will facilitate the orderly conduct of the association.
- 3.4 The Board shall meet as necessary to conduct association business. The first meeting shall be held within ~~the week~~ two weeks following the annual meeting. Special meetings may be called by the president, vice-president, or three directors.
- 3.5 Terms of office shall be 2-year terms. President, Vice-President and ~~Secretary/Treasurer~~ Secretary, and Treasurer shall be elected in alternating years. Of the six area Directors (north, south, east, west, and 2 seasonal), they shall be elected alternating years, 3 each year for 2-year terms. It is desirable to have the vice-president nominated for president to maintain continuity of effort from year to year.
- 3.6 Any vacancy on the Board may be filled by majority vote of the remaining Directors or by election at a meeting of the membership. A Director elected to fill a vacancy shall be elected to the unexpired term of his predecessor. This same procedure will be followed to fill a vacancy of an Officer-Director.
- 3.7 Quorum consists of a majority of Board members present and voting.

ARTICLE IV – OFFICERS AND DIRECTORS

- 4.1 The ~~offices~~ officers shall be President, Vice-President and ~~Secretary/Treasurer~~ Secretary, and Treasurer.
- 4.2 Directors are 4 area (north, south, east, west) and 2 seasonal members.
- 4.3 The Board may appoint such other officers and agents as it shall deem necessary from time to time. They shall hold their office for such term and exercise such powers and perform such duties as shall be determined by the Board.
- 4.4 If the office of any Director or agent becomes vacant by reason of death, resignation, disqualification, removal from office, or otherwise, the Directors then in office, although less than a quorum, by majority vote may choose a successor or successors, who shall hold office for the unexpired term of the predecessor.

ARTICLE V – STANDING COMMITTEE

To accomplish the goals of the organization, the President shall appoint the chairperson for committees: i.e. water quality, safety & security, membership, nominating, natural resources & environment or ad hoc committees and task forces as needed for special purposes and projects.

ARTICLE VI – AMENDMENTS

These By-Laws may be altered, amended or repealed by the membership at any regular or special meeting, by a majority vote of the members present at such meeting, provided due notice of such change be given to the members as provided above.

ARTICLE VII – RULES OF ORDER

All parliamentary questions shall be decided by Robert's Rules of Order, revised.
