Committee Reports

Water Quality and AIS Management

Starry Stonewort is the new threat that has come to our attention in the invasive species arena! Information on the Starry Stonewart is on the DNR website: www.dnr.state.mn.us/invasives/aquaticplants/starrystonewort.

You can also find a Star Tribune article if you google: star tribune starry stonewort.



What is starry stonewort? Starry stonewort are grass-like algae that are not native to North America. The plant was first confirmed in Minnesota in Lake Koronis, near Paynesville in Stearns County, in late August of 2015. Plant fragments were probably brought into the state on a trailered watercraft from infested waters in another state. In August of 2016, starry stonewort was confirmed in several north-central Minnesota lakes in Beltrami, Itasca and Cass counties.

Why is starry stonewort a problem? Starry stonewort can interfere with recreational and other uses of lakes where it can produce dense mats at the water's surface. These mats are similar to, but can be more extensive than, those produced by native vegetation. Dense starry stonewort mats may displace native aquatic plants.

What can people do to prevent its spread? The most important action you can take to limit the spread of starry stonewort and other non-native aquatic plants is to "Clean, Drain, Dispose".

CLEAN all vegetation, animals, mud and debris from your watercraft and any water-related equipment before you move it from one body of water to another. **DRAIN** all water from your watercraft and bait bucket, keep drain plugs out during transport, and **DISPOSE** of any unwanted bait in the trash.

Clean, Drain, Dispose is required by law in Minnesota.

On Horseshoe Lake, I have collected water samples for the Zebra Mussel Veliger monitoring program which is sponsored by Crow Wing County Land Services. One sample was taken in the west bay - north end and two samples from the east bay - north end and near boat landing. The samples will be sent in for testing on July 17.

Secchi Disk readings on July 1 were: East bay - 13.5 feet. West bay - 14 feet

Zebra Mussels Found In Lake Edward

The Minnesota Department of Natural Resources confirmed zebra mussels were found in Lake Edward and the Mahnomen Mine Pit No. 1 in Crow Wing County.

A DNR invasive species specialist confirmed an adult zebra mussel in the beach area of a Lake Edward resort north of Merrifield. The DNR confirmed a second zebra mussel about a half-mile from the initial report site, a news release from the agency said Thursday.

In the second location, a DNR invasive species specialist responded to a report of a single zebra mussel in the Mahnomen Mine Pit No. 1 near Crosby and found multiple adult mussels in the lake. The Mahnomen Mine Pit lake is connected to Pennington, Arco, Alstead, and Mahnomen 2 and 3 in the Cuyuna Country State Recreation Area.

A more extensive survey of both waters will be conducted to determine how widely zebra mussels may be present. Signs at lake accesses were updated to alert boaters to the presence of zebra mussels.

We took extensive tours of each basin looking for loons June 29 and July 2nd. Most exciting was that there were two babies and adults on the east basin. The channel watcher said she seen a baby earlier but when we saw the channel pair, they were nesting again indicating that something must have happened to it. Marlin thinks that that big northern that lives in the channel got it.

We have not seen the pair that nest in the lagoon for a long time. In an effort to find them, we asked some people sunbathing on the west lake and they said they had heard a pair fly over heading toward Pelican.



<u>Nesting Information</u>: www.allaboutbirds.org/guide/Common_Loon/lifehistory: "Loons nest in quiet, protected, hidden spots of lakeshore, typically in the lee of islands or in a sheltered back bay. Loons can't walk well on land, so nests are built close to a bank, often with a steep drop-off that allows the bird to approach the nest from underwater. They also use artificial nesting platforms, which people have offered as

alternative habitat on lakes with extensive shoreline development. Many times a nesting pair of loons will reuse the same site the following year, refurbishing their old nest instead of building a new one... The finished nest is about 22 inches wide and looks like a clump of dead grasses by the edge of the water."

DO YOU KNOW WHY NOT TO HAVE A CAMPFIRE ON THE BEACH?

In local news recently, the Whitefish Area Property Owners' Association (visit www.WAPOA.org) published an ad in the paper answering this question. WAPOA says "Everything we do is related to protecting the quality of our lakes". HLPOA is also concerned that we do our part to protect our lakes and that includes things we personally have control over.

Here is a summary of that ad:

Fire pit ash contains calcium, phosphorus, magnesium and other micronutrients which can wash out of the fire pit during rainfall and have an adverse effect on the lake by promoting plant and algae growth in the lake.

- Locate fire pits at least 25 feet from the lake to allow the run-off and ash to seep into the ground and be filtered before the unwanted chemicals can run into the lake.
- **Clean fire pits frequently** to reduce the amount of ash that can flow into the lake.
