President's Corner

The long winter is finally behind us and it's time to again enjoy the days on Horseshoe Lake!

As we look forwards to another lake season, I have listed a few key topics for you from the board..

Clean and Clear Lake-Most importantly we want to continue to keep are lake clean and free of Aquatic Invasive Species. Unfortunately, we are surrounded by infected lakes and our success is critical to take the steps to prevent the spread to Horseshoe Lake. We again will have extensive AIS inspector coverage at our landing. All weekends (F-Su) will be covered plus various other days preceding holidays, fishing tournaments etc. Our coverage will go through the end of September.

Remember when you show up at the launch, make sure your plug is out.

High water- With the water at its highest level in over 13 years, please be cognizant of high boat speed near shore, as shore erosion is more susceptible. Technically the lake has a no wake zone 150 feet from shore, unless launching or dropping off a water skier. Additionally, the channel is a NO WAKE ZONE High speeds will back fill the area we dug out 10 plus years ago.

(at considerable cost) If you park your boat with others in the channel, beware of the traffic zone and clean up before you leave.

Ice ridge Removal – In some cases, the ridges can be removed without the need to obtain a permit. Here is a link for you to check the requirements: http://www.dnr.state.mn.us/permits/ water/answers.html#iceridges

Fertilizing – Runoff from fertilizer and herbicides can end up in our lake. If lawn fertilizer is used, be sure to use very light treatments of "lake safe" Fertilizer that do not contain phosphorus (the middle number of the fertilizer analysis should always be zero).

Fireworks Etiquette– Most owners come to our lake to enjoy a natural selling. Please limit use of fireworks to 4th of July celebrations. People and pets will appreciate your courtesy throughout the summer.

4th of July Boat Parade-Please remember the annual 4th of July boat parade. It starts at noon on the 4^{th.} Our goal is to continue to increase participation. It can certainly be a creative fun time with family and friends.

Lastly let's have a safe and trouble-free summer. Remember your neighbors, be considerate in boating, limiting noise and follow the laws of proper boating.

Fisheries Management

HLPOA Ice Fishing Contest was held 10am to 2pm on Saturday January 19, 2019. Our first winter contest focused on Northern Pike of which 14 were caught and kept. It turned out to be a fun day for the 19 anglers even with the extreme cold.

Management of Northern Pike and Bullheads

The Minnesota DNR changed regulations related to possession limits of northern pike effective for the 2018 fishing season. The new limits applicable to the zone in which Horseshoe is located are an angler can keep 10 northern pike, but not more than two pike longer than 26 inches; and all from 22 to 26 inches must be released. Northern pike taken by spearing follow the same rules except one pike may be between 22 and 26 inches or two larger than 26 inches. These regulations were implemented to encourage the harvest and reduce the overabundance of smaller northern pike, which feed on perch that are important to the walleye population.

Several years ago the association worked with the DNR and a private company to net northern pike and bullheads for removal from the lake. Due to poor weather conditions, many fish were removed but not as many as anticipated. There are no plans at this time for additional netting.

The board continues to encourage the removal of northern pike in accordance with the state regulations, meaning if you catch fish within the prescribed limits, do not release them back into the lake. The limit on bullheads is 100 with no size restrictions so do not release any of them if you are under the limit. Jim Peterson. Seasonal Director

Minnesota Personal Watercraft Laws

You Must...

- 1. Wear a USCG approved life jacket.
- 2. Travel at slow-no wake speed (<u>5 mph or less</u>) within <u>150 feet of</u>:
- * non-motorized boats
- \ast shore (unless launching or landing skiers directly to or from open water)
- * docks
- * swim rafts
- * swimmers
- \ast or any moored or anchored boat.
- 3. Operate only from 9:30 a.m. to 1 hour before sunset.
- 4. Use the cutoff lanyard properly.
- 5. Obey operator age/permit laws for those younger than 18 years old.

You May Not...

- Chase or harass wildlife.
- Jump the wake of another boat within 150 feet of the craft.
- Operate a personal watercraft in a manner that endangers life, limb or property.

Protect Your Sport... Respect your neighbors

- don't operate for long periods in the same area!
- or <u>near occupied boats or shore</u>!

This is only a summary of the laws as of January 2014 and is required to be visible to the operator on all personal watercraft in Minnesota. Good Neighbor Reminder

An unsigned letter from a lake property owner was sent to the board that had some important reminders for lake owners. In summary:

- 1. There were concerns with the increased amount of partying in the channel that has resulted in litter and other waste left behind. We have always prided ourselves on being a clean lake.
- 2. Drinking and driving while impaired is just as relevant and as big a concern on the lake as on a road. Be aware.
- 3. Another concern in this letter referred to the traffic from Wave Runners, Jet Skis, or other personal watercraft not being responsible. They have been driving too close to docks, swimmers, fisherman, paddle boards, loungers, etc.

The board felt we should include a summary of the letter as these topics are something we all need to be concerned about when on the lake. If attending a party, plan on having a designated driver. If visitors or extended family are bringing a boat to the lake, share what a "clean" boat is and raise the awareness of AIS prevention.

We need members of our families and/or visitors to know the laws, and especially "<u>what a safe</u> <u>distance looks like</u>" from a dock. Slow down and move back. Be aware of your surroundings. We don't want any accidents to innocent swimmers, etc. resulting from personal watercraft (or even boats and pontoons) <u>driving too close to docks as</u> <u>they very often do</u> (swimmers may be nearby)! Last year, we also had reports of personal watercraft chasing loons.

In general, by being proactive, we are protecting our natural heritage. Being "Up North" brings to most people's minds a pristine picture of our natural surroundings - trees, clean lakes, and animals. When in the boundary waters, you take out everything you bring in—including the smallest things even gum. Same on the lake. We need to pick up after ourselves. So again, we individually, know the

rules, but do our visitors and the youngest members of our families? Help grow their knowledge.

Please only qualified recycling-No mattresses, furniture, etc.


- Household recycling (Paper/Glass/Tin/Cardboard/Plastic) separation not required.
