Again HLPOA has contracted to double the 300 hours that Crow Wing County has allocated. The resulting 500-600 hours will cover most weekends and upcoming holidays. It is an important endeavor to keep AIS out of our lake. These pests can travel on any watercraft and affect the natural habitat of our water and shores.

Thank you members for your support to voice your opinion on expanding the increase of homes and population by signing a petition of opposition. An overview of this proposal is included below. An Advisory Board Meeting scheduled by Crow Wing County Land Services is pending at the old courthouse in Brainerd. Board members are encouraged to attend and will keep the membership advised at to the outcome of this meeting. We are also planning to complete an Environmental Assessment Worksheet for the Office of Land Services.

We will continue our program of water testing this summer and Jerry Martin and his team will be reporting on water quality.

HIDAWAY BAY DEVELOPMENT




The HLPOA Board of Directors and Officers unanimously voted to oppose the Hideaway Bay on Horseshoe Lake Development. The project proposes to add thirteen additional residences on the lake with docking capability.

Here are the likely ramifications:

- AIS monitoring of the public access may need to be increased at the expense of the HLPOA.
- Our shoreline and lake environment could be impacted by additional residents and boat traffic.
- The potential increase in boat traffic from the project will make it more challenging to check and maintain our clean AIS-free lake.
- Setting this precedent can increase the potential for other landowners to create similar developments and additional lake congestion.

COMMITTEE REPORTS

Water Quality and AIS Management



HLPOA will continue to monitor water quality this year by taking water samples and secchi disc readings May through September. This data is collected for the Minnesota Pollution Control Agency and Crow Wing County Land Services. HLPOA has been monitoring water quality since 2001. Since 2004, our water samples and secchi disk readings have been tested and tracked by RMB Environmental Laboratories. RMB's summary of trends for both East and West Horseshoe, state that Phosphorus, Chlorophyll and Tropic State Index are all improving. Bear Alert!

If you see a bear, slowly back away; do not turn your back on the animal.

- **NEVER run from a bear.** Don't approach a bear just quietly move away and leave the area. However, if a bear does approach you, make yourself look big, make loud noises, clap your hands, and continue to back away.
- Store garbage in bear-resistant garbage cans or dumpsters. Keep garbage inside a secure building (not a screened porch) until the morning of pickup.
- If there is not a secure building to put bear attractants in, erect an energized fence around trash or any other item attractive to bears (e.g., fruit trees, animal feed, gardens and compost piles).
- If you feed birds, hang birdfeeders 10 feet up and 4 feet out from the nearest trees. Use a rope and pulley system to refill birdfeeders, and clean up spilled seeds daily.

Stay Safe Minnesota

Minnesota Lakes and River Advocates

There is a new program that will help your Lake Association protect Minnesota's iconic loons.

Get the Lead Out is a program at the Minnesota Pollution Control Agency under a cooperative agreement with the U.S Fish and Wildlife Service. The mission of GTLO is to protect and restore the population of common loons in Minnesota by reducing their exposure to lead-based fishing tackle. This is done through education, outreach, and advocacy/intervention activities that promote the use of lead-free fishing tackle. In the past, we've done tackle exchanges, set up display stands of lead-free tackle at shops, and education/outreach at sports shows.

Lead poisoning is a leading cause of death for loons. The current national estimate is that 25% of loon deaths are caused by lead poisoning.

Loons

- Consume fish with lead tackle attached. The fish can either still be on the line or broke off with tackle attached.
 - Pick up pebbles at bottom of lakes to store in their gizzards to help them grind up and digest their food.
 - Pick up lead tackle at the bottom of a lake and swallow them.
 - Strike at fishing tackle being retrieved.

Solutions/Strategy:

These collection kits will allow organizations take in lead tackle to be disposed of and recycled properly at household hazardous waste facilities, and will also have lead-free tackle to distribute. In short, the kits will help to make sure that there is more lead-free tackle out there, and less lead tackle. This is especially crucial for lake associations and lake residents, as they have a direct connection with lakes and the loons that may be present on them.

Solutions and things people can do:

- Buy & use lead-free tackle.
- Share about the dangers of lead.
- Encourage others to use lead-free tackle.
- Ask retailers to carry lead-free tackle.
- Dispose of lead tackle properly.
- Make your voice heard to your elected officials.

- ➤ Transfer Station now open Saturdays 9 a.m. 3 p.m. through October. If you arrive and gates are closed, contact Jim Roach (218) 765-3638. <u>Joachim@Brainerd.net</u>.
- A new Mission Township Newsletter is sent semi-annually that will provide a window into what the township board is planning. The board is responsible for the supervision of the township assets and amenities. This includes the fire department, 20.1 miles of road and the township park.
- ➤ 6 roads were identified as needing reclamation at a cost of \$1.7 million.
- There are openings to join the Roads and Park committees. Go to the website at <u>missiontownship.org</u> if you would like to join this committee.
- > The fire department has several new hires and they continue ongoing training and skill development. New equipment including protective gear and a new fire truck are to be integrated into a five-year capital expenditure plan.
- We are waiting to hear on DNR grant applications for Mission Park. This includes an upgrade to the playground, ball field, fencing, trails, pavilion roof, basketball court and add 2 pickle ball courts. We will be notified in early July. If approved projects would take place over the next year. Special thanks to Jim Peterson with well over 200 hours writing and rewriting the grant application. If the grant is not approved the Mission Board will integrate the cost of the recommendations into the five year expenditure plan.

Light and Nutritious

Well, you don't have to sacrifice great taste to achieve healthy meals. Its grilling season and the gardens are growing! Here is a recipe that incorporates garden fresh vegetables and grilled meat. Add a brown rice casserole, fruit salad and skillet pineapple upside down cake and you have a winner. Best of all – it can all be done on the grill!

Minnesota Shish-Ko-Bobs

2 pounds round steak cubed (or sirloin) or chicken
Marinate in 2 cups barbeque sauce and
½ cup red wine, Worchester sauce (1 tsp)
salt and pepper to taste
Marinate in refrigerator for 2-4 hours
Assemble metal skewers (or wood)
Thread your favorite cleaned vegetables onto the rods:

Green and Red Peppers Cherry Tomatoes Zucchini

Whole Mushrooms Pineapple Spears
Onions Red Skin Potatoes

Grill over medium heat until vegetables are tender and meat medium to well-done.
